#### 1.0 STATEMENT OF INTENT AND OBJECTIVE OF PLAN

#### 1.1 Statement of Intent

Formaldehyde (CAS# 50-00-0) is currently used by Quatic Industries Limited (Quatic) in many processes at the facility. Quatic intends to reduce the use of this toxic substance at the facility.

#### 1.2 Objective

Formaldehyde is a main ingredient in its products and therefore cannot be eliminated. However, Quatic will strive to reduce the use of formaldehyde. This plan will determine the technical and economic feasibility of each of the proposed reduction options to determine which, if any, are viable for implementation at this time.

#### 1.3 Target

Quatic intends to reduce the annual use of formaldehyde by 3% in 2 years.

#### 3.0 REDUCTION OPTION TO BE IMPLEMENTED

To reduce the use of formaldehyde at the facility, Quatic intends to implement Option 3. Option 3 will involve moving to a closed mixing and dispensing process that will significantly reduce the amount of formaldehyde disposed of and in-turn reduce the amount of formaldehyde used at the facility.

Quatic implemented Option 3 at the end of 2016 and is operating using the new system. It is expected that the facility will reduce the annual use of formaldehyde by 3% by the end of 2018.
