1.0 STATEMENT OF INTENT AND OBJECTIVE OF PLAN

1.1 Statement of Intent

Methanol (CAS# 67-56-1) is currently used by Quatic Industries Inc. (Quatic) in many processes at the facility. Quatic intends to reduce the use of this toxics substance at the facility through the implementation of any available reduction options that are technically and economically feasible.

1.2 Objective

Methanol is a main ingredient in its products and therefore cannot be eliminated, However, Quatic will strive to reduce the use of methanol. This plan will determine the technical and economic feasibility of each of the proposed reduction options to determine which, if any, are viable for implementation at this time.

1.3 Target

Quatic intends to reduce the use of methanol by 5% in the next year.

3.0 REDUCTION OPTION TO BE IMPLEMENTED

To reduce the use of methanol at the facility, Quatic plans to implement Option 3. This option involves closing the Batch Mixing and Dispensing processes. These two processes would be connected via pipe infrastructure. The two processes would also be outfit with dedicated exhausts. The result would increase the amount of methanol released to air, due to the dedicated exhausts, however the amount of methanol disposed would be decreased by a significantly larger amount.

It is believed that total losses from this process would be reduced from 12.5% to 5%. Although air releases would increase minimally due to dedicated process exhausts in the closed system, water losses due to washing would be significantly decreased in the closed system.

Quatic intends to reduce the use of methanol by 5% in the next year.
